You must get the job offer before you apply to come to Canada as a Federal Skilled Worker. A valid job offer has to be: for continuous, paid, full-time work (minimum of 30 hours/week) that is: not seasonal; for at least 1 year; in an occupation listed as Skill Type 0 or Skill Level A or B of the NOC. If immigration to Canada within the Federal Skilled Workers Program is possible, you must then apply for permanent residence under Express Entry. But to do that, you will need to be invited to do so. Your initial Federal Skilled Worker Program application places you into a pool with other eligible workers.

What are the minimum requirements to apply as a federal skilled worker? The minimum requirements for federal skilled workers are: Skilled work experience. You must have at least one year, in the last ten years before you submit your electronic application for permanent residence, of continuous full-time work experience (or the equivalent in continuous part-time work) in a skilled occupation listed in Skill Type 0, or Skill Level A or B of the 2016 version of Canada's National Occupational ...

What are the minimum requirements to apply as a federal ...

The Office of Immigration considers applications from intermediate and low skilled workers based on local labour market requirements and conditions. At the time of application, intermediate and low skilled workers must meet all eligibility criteria and have six (6) months of work experience with the Nova Scotia employer supporting the application.

Federal Skilled Worker Program (FSWP) Thousands of skilled professionals are needed to work in Canada in a range of occupations that require a post-secondary education (such as a university degree), but many employers cannot find enough qualified Canadian workers to fill job openings.

In order to be eligible to apply under the Federal Skilled Worker Program, potential candidates must meet the minimum requirements for work, language ability, education and obtain at least 67 points under the program's 100-point grid.
